# 5. OLD BUSINESS

## 5.1 AudCom Baselines Update Ad Hoc Briefing

Thomas Koshy updated AudCom about the work of the baselines update ad hoc, and mentioned that the near-final draft of the Standards Committee baseline has been distributed to AudCom and staff for comments. He thanked the ad hoc and Lisa Weisser, and staff for their efforts, and thanked AudCom for reviewing the document. The timeline for the completion of the baselines update was discussed, but given the number of comments received both during and following the December AudCom meeting, there will need to be additional work by the ad hoc for the Standards Committee baseline, which will push the timeline forward.

AI: During the discussion for two Standards Committee P&P reviews, topics were addressed that will be brought to the AudCom baselines update ad hoc to determine if there is a need to address them through the baseline documents.

## 5.2 Action Item Review - Lisa Weisser

Lisa Weisser reported that there were no action items carried forward from prior AudCom meetings.

## 5.3 Update on P&Ps Due in 2022



Lisa Weisser displayed the list of Standards Committees with P&P that were accepted that have not yet submitted Working Group P&P for review by AudCom. It was noted that some of the Standards Committees do not currently have Working Groups. The Standards Committees remain on the list until a Working Group P&P is submitted to AudCom for review.

Lisa also displayed the list of all Standards Committees with P&P expiring at the end of 2022 that will need to submit an updated P&P document to AudCom. One Standards Committee (CIS/SC) has requested an extension, and its P&P are expected within the first quarter of 2023.

Another Standards Committee (AES/UAS/UAV/SC) has been unresponsive to the request for an updated P&P, and AudCom made a recommendation to the SASB.

Motion: Recommend that the SASB takes an action to suspend work from AES/UAS/UAV, whose Standards Committee P&Ps expire on 31 December 2022 if the Standards Committee has not submitted its updated P&Ps to AudCom by 31 December 2022. Upon vote, the motion passed.

Note: The AES/UAS/UAV P&Ps were not submitted to AudCom by 31 December 2022, and the Standards Committee will be disbanded.

# 5.4 Committee Member Interactions/Comments RE: myProject

Markus Plessel presented an update about myProject accomplishments and the status of upcoming features of interest. AudCom members can find the myProject update presentation slides in the AudCom area in iMeet. Notes on release timing are also available in the support portal that can be found on the myProject login page.

## **6. NEW BUSINESS**

Don Wright announced that one of the IEEE MOVE trucks (please see <a href="https://move.ieee.org/">https://move.ieee.org/</a>) would be available for volunteers and staff to tour at various times during the December meeting series. He explained that when the trucks are not providing support during natural disasters, they conduct outreach for STEM education, among other activities, and he suggested that IEEE SA consider opportunities to get involved.
