## 10.2 myProject Redesign Update

Karen Evangelista gave an update on the status of the myProject Redesign. RevCom Members were asked if they wanted to participate in testing. Doug Edwards, Travis Griffith, Gary Hoffman and Adrian Stephens volunteered.

#### 11. NEW BUSINESS

## 11.1 Checklist Review - Stephens

Adrian Stephens called in and gave a presentation on the RevCom Checklist. An ad hoc was created to review the checklist with Adrian Stephens as the chair. The members of the ad hoc are: Doug Edwards, Karen Evangelista, Travis Griffith, Soo Kim, Gary Robinson, Erin Spiewak, Mehmet Ulema and Yu Yuan.

## 11.2 CSV Comment File – Stephens

Adrian Stephens gave a presentation on the use of .csv files and is it a good enough file type to use. Users have to format the .csv file when open in order to read it and review the material. It was noted that .xlm or .xlsx would be better options. RevCom Members agreed that this is a change that would be helpful if these other file types were available in myProject. Adrian Stephens and Gary Robinson have volunteered to be liaisons to staff on behalf of RevCom for this activity.

**AI:** Staff to research/determine if we could change it in myProject and what effort it would take.

#### 11.3 Mandatory Coordination

Gary Hoffman started the discussion about SCC14 reviewing the standards and being a mandatory coordination body. When the project is on the RevCom agenda, SCC14 is supposed to review it, but there have been no comments from the committee in recent years. It was stated that SCC14 does not have a chair at present and does not have the manpower to review every standard. There was a submittal to ProCom to have the SCC14 coordination removed from the Standards Board Operations Manual but there was a question as to who is doing or would do the review. Sam Sciacca stated that the staff editors review each draft standard for metric compliance during the MEC stage. When it is technical the staff reaches out to a member of SCC14 for guidance. Yvette Ho Sang stated that the staff editors use SI 10 as a guidance document to review the draft for metric compliance.

There was a motion by Gary Robinson, seconded by Travis Griffith stating that RevCom recognizes SCC14 has limited resources and IEEE staff should take over the review and seek advice from SCC14 as needed. The motion passed unanimously.
